Glossary of Terms

Term	Definition
Agent	means the person acting for and on behalf of another person when opening an account with the Malta Stock Exchange plc. For the avoidance of doubt, this refers to a situation where the account is opened in the name of the Agent and the Agent is acting on behalf of the Principal when opening the account.
Close Associates	means: a. a natural person known to have joint beneficial ownership of a body corporate or any other form of legal arrangement, or any other close business relations, with that politically exposed person; or b. a natural person who has sole beneficial ownership of a body corporate or any other form of legal arrangement that is known to have been established for the benefit of that politically exposed person.
Immediate Family Members	includes, but is not limited to: a. the spouse, or a person considered to be equivalent to a spouse; b. the children and their spouses, or persons considered to be equivalent to a spouse; and c. the parents
Member	Any member of the Malta Stock Exchange authorised to trade on the account for and on behalf of an account holder via the trading infrastructure operated by the Malta Stock Exchange.
